Additional costs will arise by postal fees and packing, depending on the country of delivery. You will get a detailed offer from us by E-mail. For companies in the European Union, Switzerland, North America and Australia the software can be paid on invoice. In all other cases charges have to be paid in advance. When paid in advance in addition to the supply of a CD the software can be transferred by download after the payment has been credited to our bank account. The respective URL will be communicated to the customer and will be valid for two weeks.

A value added tax (VAT) will not be charged. Additional taxes in the country of the customer like e.g. import taxes have to be paid autonomously by the customer.

Due to competition regulations the software PS-PERMAG can not be purchased by producers of permanent magnets. A producer of permanent magnets is defined as a company, which commercially manufactures permanent magnetic bodies by methods like casting, sintering, injection molding, compression molding or similar methods. Companies however, which do not manufacture but machine, modify or sale magnetic bodies only, are not considered as producers in this context and may purchase the software.

During the installation of the PS-PERMAG software you have to accept the license agreement which will be shown during the installation procedure, see also below.

License Agreement

The following license agreement has to be accepted when installing the software:

ATTENTION: THE USE OF THE PS-PERMAG SOFTWARE FROM T.SCHLIESCH IS BASED ON THE REGULATIONS OF THE FOLLOWING SOFTWARE LICENSE AGREEMENT. WHEN YOU USE THIS SOFTWARE YOU DECLARE YOUR ACCEPTANCE OF THIS SOFTWARE LICENSE AGREEMENT.

If you do not have any other signed agreement with T.Schliesch, the following license regulations will determine your authorization to use the PS-PERMAG software.

License grant: T.Schliesch grants you a license to use a copy of the software. The use includes saving, loading, installing, execution and display of the software. You are not permitted to modify the software or to deactivate its license and control functions. When the software is licensed for the use by more than one person, the maximum number of permitted users may not be exceeded.

Property rights: The software is property of T.Schliesch. The license does not grant you any property rights or claims for this software. It also does not grant you any rights to sell it. T.Schliesch will demand legal claims in the case these license regulations are hurt.

Copies and adaptations: You are only permitted to make copies or adaptations for your own back up and only then, when copying or adapting is part of your authorized use of the software. It is strictly prohibited to copy the software onto a public network.

No disassembly or decompilation: Without written permission by T.Schliesch you do not have the right to disassemble or decompile this software. By request you have to turn over detailed information of the disassembly or decompilation to T.Schliesch.

Transfer: This license will end automatically if the software is given to an other party. A transfer of rights to other companies or persons is not permitted.

Termination: T.Schliesch has the right to terminate this license, when the regulations which are included are not considered. When the software is terminated you have to destroy all copies, adaptations and all parts of the software on any sorts of media immediately.

Export: You are not permitted to export the software, copies or adaptations, when this leads to a hurt of laws or export regulations.

Liability: T.Schliesch and all authorized persons or companies who are permitted to sale this software, will not be liable for damages or disadvantages, which are caused by an erroneous use of this software or which are caused by errors in the software itself.
