Additional costs will arise by postal fees and packing, depending on the country of delivery. You will get a detailed offer from us by E-mail. For companies in the European Union and Switzerland the software can be paid on invoice. In all other cases charges have to be paid in advance. When paid in advance in addition to the supply of a DVD the software can be transferred by download after the payment has been credited to our bank account. The respective URL will be communicated to the customer and will be valid for two weeks.

A value added tax (VAT) will not be charged. Additional taxes in the country of the customer like e.g. import taxes have to be paid autonomously by the customer.

During the installation of the PS-PERMAG software you have to accept the license agreement which will be shown during the installation procedure, see also below.

## License Agreement

The following license agreement has to be accepted when installing the software:

ATTENION: THE FOLLOWING SOFTWARE LICENSE AGREEMENT REGULATES THE USE OF THE PS-PERMAG PROGRAM FROM THOMAS SCHLIESCH. BY USING PS-PERMAG YOU DECLARE THAT YOU ACCEPT THESE LICENSE AGREEMENT REGULATIONS WHICH ARE EXPLAINED IN DETAIL BELOW.

The following details of the PS-PERMAG license agreement are valid if you do not have any other signed agreement with the author of the software, Mr. Thomas Schliesch.

License grant: You are granted a license by Thomas Schliesch. You may install, load, execute or display the software. You are not allowed to change the software or make the license and control functions inactive. In case a license is given for more than one person the maximum number of users is not allowed to be exceeded.

Property rights: The software is property of the author Mr. Thomas Schliesch only. The license does neither grant any rights or claims for PS-PERMAG nor does it allow any rights to sell it. Thomas Schliesch will demand legal claims if the license regulations are violated.

Copies: You are permitted to make copies for your own backup purposes only. Publishing PS-PERMAG on public networks is prohibited.

Disassembly or decompilation: It is strictly prohibited to decompile or disassemble the software.

Transfer: It is not permitted to transfer any software rights to other parties. Your license will end immediately and automatically after such a transfer.

Termination: Thomas Schliesch will terminate all your rights to use the software if any of the license regulations has been violated. After such termination you have to delete all copies and all parts of the PS-PERMAG software on all your media.

Export: The software or its copies may not be exported to other countries when this would mean a violation of laws or export regulations.

Liability: Thomas Schliesch and all authorized persons, companies or organizations who are allowed to sale licenses of this software, will not be responsible for damages or disadvantages which are caused by the use of PS-PERMAG. This includes damages or disadvantages that may be originated by an erroneous use of the software as well as by errors in the software itself.
